IRC Roundtable/Symposium Research Event

This event was funded by the Irish Research Council (IRC) and the Policing Authority under the New Foundations awards scheme which brings researchers and community organisations together to collaborate on projects that will have a tangible impact on societal and community issues. The attendees were addressed by Minister of State for Mental Health and Older People Mary Butler TD and Minister of State at the Department of Further and Higher Education, Research, Innovation and Science Niall Collins TD. Superintendent Andrew Lacey who is the implementation team leader for Crisis Intervention Teams (CIT) and Community Safety Co-Response Model in the Ireland organised the event as the research awardee with the Irish Research Council.





Centre for Crime, Justice and Victim Studies

North-South Criminology Conference Hosted by CCJVS

On Friday 16th September the Centre for Crime, Justice and Victim Studies hosted the Annual North-South Criminology Conference in the Analog Building. The conference theme was 'The Crime Experience Post Pandemic: Experiences and Practices' and featured speakers from each of the member institutions of the North-South Criminology committee. A poster competition for PhD candidates

also featured entrants from the third level institutions represented at the conference. The event was organised by Dr Susan Leahy, Director of the CCJVS, and marks the first of a series of events celebrating the 25th anniversary of the CCJVS.



Celebratory Event for An Garda Síochána Graduates



In September 2022 a celebratory event for An Garda Síochána graduates from the BA in Applied Policing programme was held on the University of Limerick campus. as for the 1,835 Garda who graduated from UL in-absentia due to the COVID-19 pandemic. UL Provost and Deputy President Professor Shane Kilcommins welcomed representatives from the Garda College and graduates from the BA in Applied Policing. Chief Superintendent Pat Murray, Superintendent Aidan Minnock and Superintendent Brian Murphy from Templemore Garda College were among those who attended the ceremony, together with Associate Vice President Student Engagement, Dr Patrick Ryan, Interim Executive Dean Faculty of Arts, Humanities and Social Sciences (AHSS) Dr Sandra Joyce and colleagues from the AHSS faculty

Chief Superintendent and Director of Training in Templemore Pat Murray said: *“Working in collaboration with University of Limerick*

has harnessed an opportunity to nurture a culture of transparency and accountability while professionalising Police Training to allow improved Policing Services to Communities right across the country...The success of the collaborative approach in relation to this programme has allowed An Garda Síochána deepen its links with University of Limerick in further professionalism across a number of areas of Police Training in Post Graduate courses delivered in specialist policing areas.”

UL accredits the Garda Síochána level 7 and level 9 training programmes; it provides an online level 8 top up programme in Applied Policing for members of An Garda Síochána, and an MA in Serious Crime Investigation for those serious crime investigators who have completed the postgraduate diploma in serious crime investigation. UL and the Criminal Assets Bureau also work together on a Postgraduate Diploma in Proceeds of Crime and Asset Identification.



Building UNESCO Sustainability Goals into the Law Curriculum

On the 8th April 2022 Dr John Lombard, senior lecturer in the School of Law, organised an event on “Building UNESCO Sustainability Goals into the Law Curriculum.” Caroline Hayes, senior lecturer in Aston University, spoke about good practice and experience in using the UNESCO SDGs to inform and shape teaching and learning. The goals of the event were also to explore strategies for enhanced student success and the development of graduate attributes through community outreach initiatives grounded in SDGs, evaluate and consider the use of a multi-disciplinary approach in responding to the challenge of sustainability at module and programme level and identify national and international trends relating to the incorporation of SDGs in higher education. The event was funded by the National Seminar Series.



Plassey Review Launch 2022

In spring the School of Law was delighted to host the launch of the *Plassey Law Review 2022*. The launch took place in the A&L Goodbody Appellate Courtroom and attended by editorial board, student representatives and faculty staff. *The Plassey Law Review* is a student-run law review established at the University of Limerick. The Review will publish articles and case notes on legal topics submitted primarily by law students or graduates from UL and other universities. The Review is established in conjunction with the School of Law at the University of Limerick and will be overseen by an Editorial Board comprising students and an Advisory Board comprising members of the faculty.



Research and related activity in the School of Law

Oireachtas Committee Presentation

Dr Lydia Bracken was invited to present to the Oireachtas, on 1st February, about her surrogacy research. Presenting her research before the Oireachtas Joint Committee on Children, Disability

Equality and Integration on Surrogacy, Dr Bracken argued that surrogacy must be subject to specific legal regulation in order to comply with the best interests principle and that law, policy and practice in the area must be shaped by children's rights and research on children's experiences. Dr Bracken's contribution was referred to in local and national news outlets



Irish Supreme Court Review Conference

In November 2021, two members of staff from the School of Law presented at the third annual Irish Supreme Court Review Conference. The event considers the major cases decided by the Supreme Court in the previous year. Dr Laura Cahillane presented on: *'Damache v Minister for Justice and the Inexorable March of Fair Procedures'* and Eoin Quill presented on *'Cantrell v AIB'*. Papers from the conference are to be published by Clarus Press in the third volume of the Irish Supreme Court Review journal in 2022.

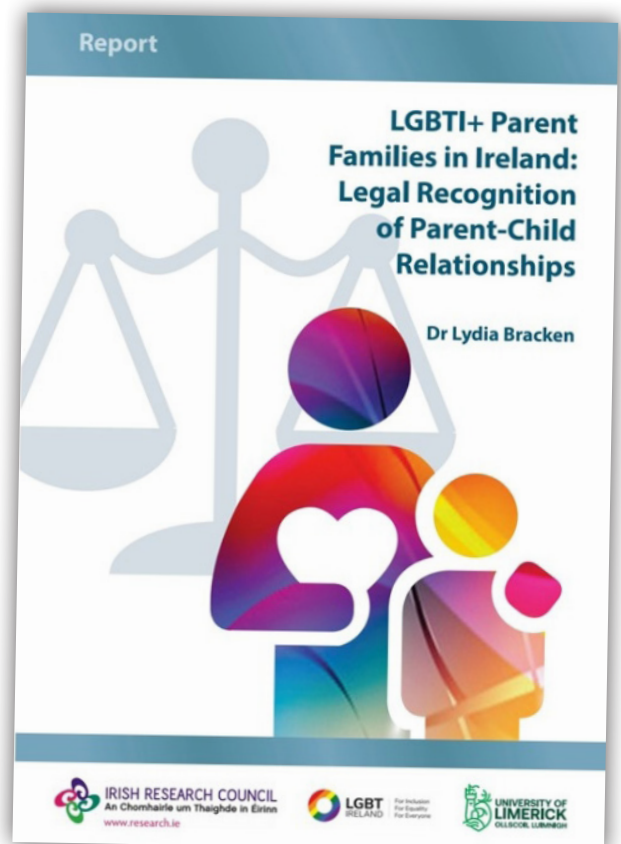


ECRI Task Force on LGBTI Rights



On 30 November

2021, Dr Lydia Bracken was invited to present to the European Commission against Racism and Intolerance (ECRI), a Council of Europe body, to inform the development of a future General Policy Recommendation on LGBTI issues. Lydia presented to the ECRI on her current research on LGBTI+ parent families and the legal issues facing such families in Ireland and Europe. Other speakers invited to present to the ECRI on this occasion were Professor Alina Tryfonidou (Neapolis University Pafos), Professor Robert Wintemute (King's College London) and Dominique Boren and Daniel Martinovic (NELFA - Network of European LGBTIQ Families Associations).



Lecturer Gives Evidence to UK's House of Commons on Cohabitation Law.

In March 2022, Dr Kathryn O'Sullivan from the School of Law provided oral evidence to the House of Commons' Women and Equalities Committee in the UK as part of its investigation into the rights of cohabiting partners. The invitation to discuss the Irish experience of undertaking cohabitation law reform arose as the Committee investigate the equalities issues around cohabitation, how cohabitation



rights could be strengthened and what legal protection for cohabitants could look like and how this might be introduced. A report on the issue is due for publication and presentation to the UK Parliament later this year.



Oireachtas Committee on Gender Equality

Dr Laura Cahillane was invited to address the Oireachtas Committee on Gender Equality on how the recommendations of the Citizens' Assembly on the Constitution can be implemented. The Committee met in private session in March 2022 and Dr Cahillane provided advice on the various options open to the committee in terms of potential constitutional amendments. Dr Cahillane previously worked with the Citizens' Assembly on the questions of equality, the woman in the home, and the definition of the family in the Constitution. It is hoped that a referendum will be held on these issues next year..



REPPP Activities



ACJRD Annual Conference “Criminal Justice and Public Health: Policy and Practice Post-Pandemic”

REPPP team member John Reddy presented at the 24th Annual Conference of the Association of Criminal Justice Research Development, on Friday the 8th of October 2021. John spoke about REPPP's 2020 study of young people in GYDPs and the first months of the Pandemic and first lockdown and how youth justice workers' 'Pandemic experiences' have the potential to strengthen and guide future practice.

UK Evaluation Society (UKES) 2022

On the 24th of May 2022, Catherine Naughton and Jackie Dwane of REPPP presented at the UK Evaluation Society's Annual Conference, *Re-imagining Evidence and Evaluation – Politics, Context, Challenges*. Catherine presented on the evaluation of the Greentown Project on the 24th of May. The presentation was titled 'The Greentown Project: Policy-led evaluation of a multi-

faceted youth crime intervention aimed at multiple ecological levels.' Jackie presented on the implementation evaluation of the Action Research Project on

25th of May. The presentation was titled 'Co-creating change; practitioners as implementation evaluators of co-designed relational practice'



Wilton Park Event May 2022

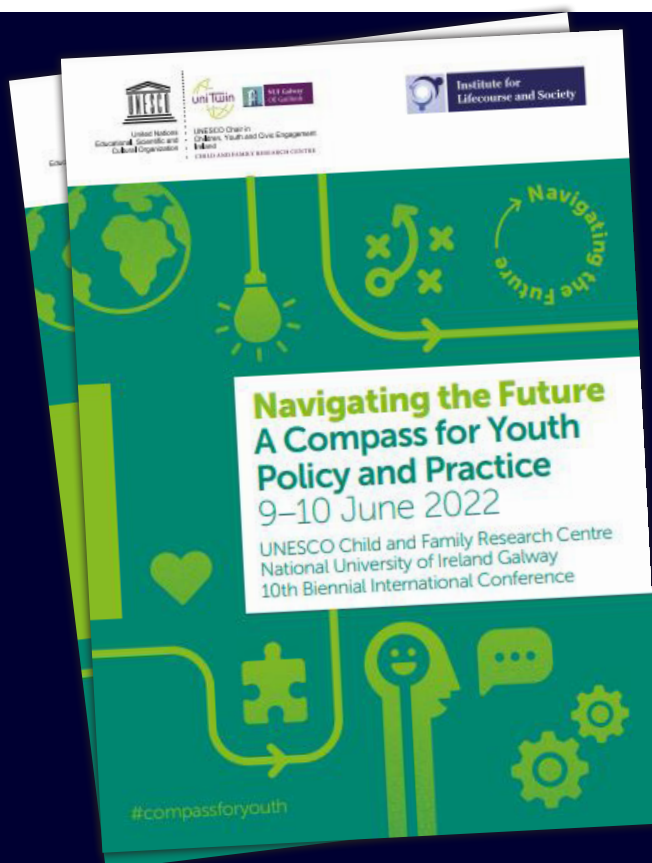
Seán Redmond participated in an international think-in on the future of evaluation in Wilton Park, Sussex, England, sponsored by the World Bank. The meeting involved authors for a series

of books examining challenges to the science and craft of evaluation in recent years. Seán has co-written a chapter with Dr Richard Boyle *'Evidence as enlightenment versus evidence as certainty: appropriate uses of evaluative information to inform policy in a post-truth world'* using youth justice and water governance as complimentary and analogous case examples.

Gender Based Abuse Research Award

Dr Susan Leahy was presented with an award for 'Best Project on Engaged Research in Domestic, Sexual and Gender-Based Abuse' at the Research GBA (Gender Based Abuse Research and Knowledge Hub) Online Conference on 'Best Practice in Engaged Research & Research Translation in Domestic

Sexual and Gender-Based Abuse' on the 10th June 2022. The Research GBA project is funded by the Irish Research Council. This aim of the project is to promote and facilitate partnerships between a wide range of stakeholders researchers, policy makers, the criminal justice system, community organisations and people directly and indirectly affected by gender-based abuse. The project is managed by Haven Horizons and the EDGE (Exploring Diversity, Gender and Equality) research group at the Technological University Shannon Region.

IRC New Foundations

In March 2022, Dr Alan Cusack and Andrew Lacey (PhD) were awarded New Foundations funding for their Crisis Intervention Team project. The project aims to inform the design and implementation of a Crisis Co-intervention Team in Ireland. It also represents a constituent element of An Garda Síochána's realisation of the procedural reforms recommended by the Commission on the Future of



Policing in Ireland (2019). A Round Table Symposium was held in April, led by international experts

in crisis intervention on the needs of vulnerable persons when interacting with law enforcement.

Stable Lives Safer Streets North-South Funding Award

In March 2022, the Stable Lives Safer Streets project was awarded over 3million in funding from the North-South Research Programme. The funding has facilitated the establishment of the Stable Lives Safer Streets All Ireland Research hub. The hub builds on previous policy-led research in Youth Crime by both Research into Policy Programmes and Practice Project REPPP, School of Law, University of Limerick and The Violence Prevention Lab, Queens University Belfast and in Implementation science by the Centre for Effective Services. The hub will provide evidence about accessible, practical approaches to understanding and responding to youth crime, criminal exploitation, and community safety. Policy makers, programme designers and practitioners can use this evidence to make more effective and efficient decisions. The Hub will enable a sustainable

cross-border approach for evidence building and its use in developing good policy and practice. The Stable Lives Safer Streets hub is led by Dr Catherine Naughton, REPPP, School of Law, UL, in partnership with Dr Colm Walsh, The Violence Prevention Lab, QUB and CES.



National Success for UL Medio-legal Research Consortium

On 22 December 2021, the HSE Open Access Research Awards were announced in an online ceremony. A paper authored by a team of international experts

from the University of Limerick, University of Galway, University College Cork, Trinity College Dublin, University College Dublin and the University of Cambridge was awarded the inaugural Special Merit Prize at this ceremony. The paper was derived from a study that was led by Professor Gautam Gulati, Dr. Alan Cusack, Professor Colum Dunne and Professor Shane Kilcommins at the University of Limerick.



School of Law Lecturer Receives AHSS Excellence in Teaching Award 2022

In March 2022, Dr Margaret Fitzgerald O'Reilly won the AHSS UL Excellence in Teaching Award. Awards for teaching are based on a comprehensive review of a range of teaching and learning related activities and engaging in these award processes provides clear evidence of commitment to teaching and performance as a teacher.



Appointment to Royal Irish Academy Committee.

In May, Dr Laura Cahillane was appointed to the Ethical, Political, Legal and Philosophical Studies Committee of the Royal Irish Academy. 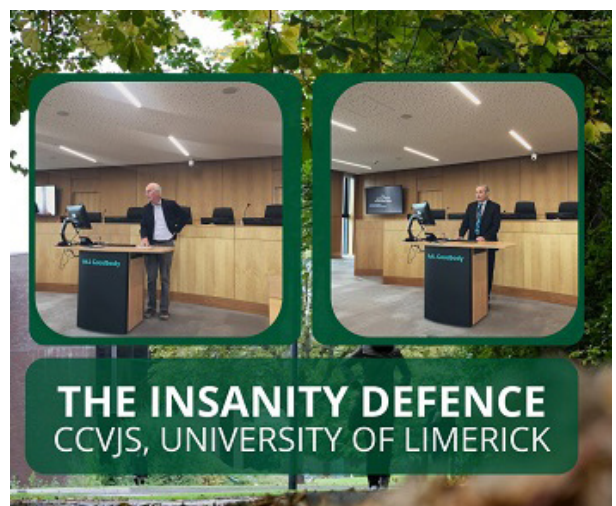

The event was co-ordinated by Dr. Alan Cusack and Professor John Bogue (NUIG) and was supported by Fullbright Ireland.



Sports Law Seminar

The Sports Law, Governance and Practice Research Cluster was delighted to have Prof. Mark James, Professor of Sports Law and Director of Research as the Manchester Law School, Manchester Metropolitan University launch the Research Cluster with his seminar on 'Athlete Activism at Major Sporting Events' on 6 September 2022. 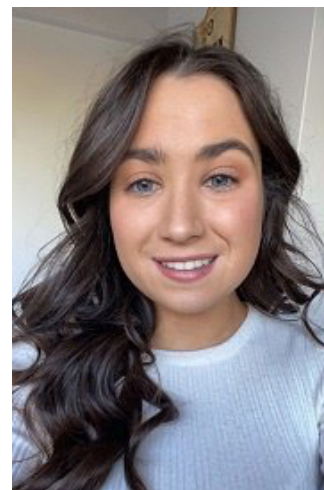
U20 Grand Slam Champion 2022

April 2023. I chose my career path as it is something I have always had an interest in. Law itself is so diverse

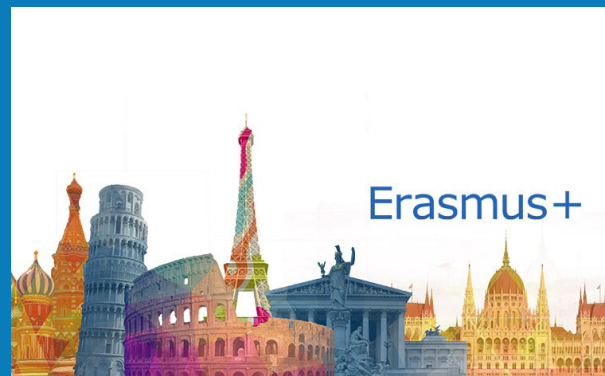

Curriculum Development and Engagement with External Stakeholders

Minister launches UL Programme to Train Intermediaries for Justice Work



In May 2022, the Minister for Justice Helen McEntee TD announced the launch of a new qualification programme at the University of Limerick to train intermediaries who will help vulnerable people, including sexual abuse victims and children, when giving evidence in the justice system. The programme is the first of its kind in Ireland and will equip professionals, usually with a background in speech and language therapy or a cognate discipline, with the skills and expertise necessary to assist witnesses who have communication difficulties in providing evidence.

Launching the programme Minister McEntee said, *"I am delighted that my Department has been able to collaborate with the University of Limerick to provide a suitable*

course to train intermediaries to the required standard.... Once qualified, they will have an essential role in assessing the communication needs of vulnerable witnesses and to advise An Garda Síochána, advocates and the court on the steps needed to assist such witnesses to give their best evidence."

The diploma is an interfaculty postgraduate training programme between the School of Allied Health and the School of Law. The project team who designed the programme include Dr Aoife Gallagher, Dr Aine Kearns, Dr Alan Cusack and Professor Sean Redmond.

New Graduate Diploma in Intelligence Management

On 5th September 2022, the School of Law at the University of Limerick was delighted to welcome twenty seven senior-ranking members of An Garda Síochána onto the School's newest postgraduate programme- the Graduate Diploma in Intelligence Management. The programme was launched by course director, Dr. Alan Cusack (School of Law) together with Superintendent Seán Fallon (Garda National Roads Policing Bureau). Candidates also received a warm welcome address from Assistant Commissioner, Crime & Security Intelligence Service, Orla McPartlin.

Representing the first programme of its kind in Ireland, this new Graduate Diploma in Intelligence Management (Level 9) is delivered over one year through a dynamic, co-curricular model of instruction which involves residential modules at the University of Limerick with assistance from the Garda College in Templemore, coupled with clinical experiential learning within An Garda Síochána. The programme has been specifically designed to provide course participants with a greater understanding of the nature of the GNCSIS region and how the distinct but interconnected sections within it function both in their individual capacity and collectively to deliver this policing and security service.



Speaking about the new diploma, Assistant Commissioner Orla McPartlin, GNCSIS said, *"The development and delivery of this academic programme aims to further strengthen and promote the ethos of intelligence-led policing within An Garda Síochána by embedding the National Criminal Intelligence Framework into our organisational skeleton through innovation, problem-solving and the professionalisation of our national intelligence model"*

Dr. Alan Cusack, Law Faculty, University of Limerick said *"The School of Law was delighted to work with our Garda colleagues in the design and delivery of this innovative, co-curricular programme which aligns with the recommendations of the Commission on the Future of Policing in Ireland and lays the foundation for a new qualification."*

Launch of the Matheson Scholarship in Law Plus

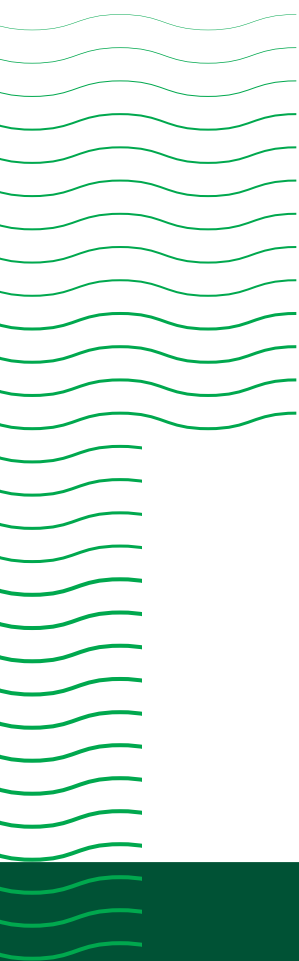
