<b>Application</b>	Coordinators nominate students by filling in the e-form, and submit it to CIA by the deadline listed above. Then, students apply through the online application and submit the required materials to CIA electronically. Hard copies of application materials are not required.

**Learning Expectations:** Students are expected to attend all lectures and seminars to complete all course-related assignments and to take exams in order to receive a course grade. Students, who take the courses of BBA International Program, will not be eligible for the final exams if students have a class attendance lower than 70% of the total class time while the students, who take the courses of MIM International Program and MIF International Program, will not be eligible for the final exams if students have a class attendance lower than 80% of the total class time.

**Note:** Students are expected to take examinations at the assigned time. If students are unable to meet the expectation, there are NO any make-up examination.
